Policy for New Joining	The student will pay the fees for the full term in which student is joining for example if the student joins the school in the second month of the second term then student has to pay the fees of the second and subsequent term.

Policy for Withdrawal

Particulars	First Term	Second Term	Third Term
Tuition Fee	During the first week: Parent will pay KD 50/- and balance will be refunded. After the first week: Parent will pay the full tuition fee for the 1st term.	If the student leaves at any time during the term, parent has to pay inclusively full 1st & 2nd term fees.	If the student leaves at any time during the term, parent has to pay fees for complete year i.e. all 3 terms.
Other Payment	There will not be any refund for sold items	like books, uniforms etc.	

Policy for Dismissal

Dismissal due repeated detention: Students can be asked to leave the school at the end of the academic year upon receiving 3 suspensions during the same year.
Dismissal due unsatisfactory progress: Dismissal on the ground of unsatisfactory progress will be according to school & ministry rule.
Dismissal due unexcused absence Student can be dismissed during the academic year, if the student is absent without excuse for a period of time that exceeds the allowed limit by the school & ministry. In case of dismissal, the parent shall pay all dues up to that term.
